Scope

NSWOC Advance/L'Avancee de L'ISPSC is the official publication of Nurses Specialized in Wound, Ostomy and Continence Canada (NSWOCC). The publication will include 1-3 peer reviewed manuscripts per issue. Authors should note that this publication is indexed in CINAHL, Ebsco Publishing, and part of the EBSCOhost suite of CINAHL programs and in Cengage Learning/Gale.

Publication goal

NSWOC Advance/L'Avancee de L'ISPSC is published 3 times per year – Spring, Fall, and Winter. The deadline for manuscript submissions is as follows:

May 1 (for the September issue)

August 1 (for the December issue)

November 1 (for the March issue)

All manuscript submissions for consideration must be uploaded online at http://nswoc.ca/advance/. From here, click the box "Submit a manuscript for consideration" and follow the prompts.

Within 3 weeks of submission, the author will receive confirmation of receipt and an indication regarding suitability for peer review as the next step toward acceptance of the manuscript for publication. All manuscripts are peer-reviewed. Once peer review is completed and if the manuscript is suitable for publication, revisions will commence and the author will receive an indication as to what issue the manuscript will be published in (assuming all deadlines for revisions and proof reviews are met).

- A submitted manuscript must be an original contribution not previously published (except as an abstract or a preliminary report), must not be under consideration for publication elsewhere, and, if accepted, must not be published elsewhere in similar form, in any language, without consent of NSWOCC. On acceptance, authors must complete an Author Release/License of Copyright form. Although NSWOC Advance, its editors and peer reviewers make every effort to ensure the validity of published manuscripts, the final responsibility rests with the authors, not with the journal, its editors, or the publisher.
- Articles previously published in any other form or journal must include written permission from
 the previous publisher to reprint this item. Permission must include all author information,
 details related to the original publication and information on how the previous publisher wishes
 to be credited

Patient Anonymity and Informed Consent

• It is the author's responsibility to ensure that patients' anonymity be carefully protected. It is also the author's responsibility to verify that any experimental investigation with human subjects reported in the manuscript was performed with informed consent and following all guidelines for experimental investigation with human subjects required by the institution(s) with which all authors are affiliated. Authors should conceal patients' faces and remove patient names from figures unless they obtain written consent from the patients and submit written consent with the manuscript.

Ethical Statement

If applicable, all studies that involve human subjects must include the name of the institutional
review board or human ethics committee and the approval number. You must identify the
institution, university or faculty that reviewed your study procedures. If your study was
reviewed and deemed exempt from individual consent, please include the name of the
institutional review board or human ethics committee that deemed this exemption and the date

Conflict of Interest

Authors must state all possible conflicts of interest including financial, consultant, institutional
and other relationships that might lead to a conflict of interest or bias. All sources of funding
should be acknowledged in the manuscript. If there is no conflict of interest, this should also be
stated as none declared.

• Industry partner submissions on basic science and disease are allowed. Studies and publications that are evaluations of skin, wound, ostomy, or continence products, will not be allowed, unless it is a randomized controlled trial.

Guidelines

The Editorial board of the *Nurses Specialized in Wound, Ostomy and Continence (NSWOC) Advance* have developed guidelines for prospective authors submissions.

Publication Categories

The Editor-in-Chief of NSWOC Advance welcomes submissions (1,000 – 5,000 words unless otherwise specified) in the form of:

- Case studies/clinical reports that will enhance or challenge critical thinking skills (template for Case Study submissions being developed)
- Research summaries with a clear description of study design, study limitations, implications to practice, and declared sponsorship/affiliation
- Innovative program descriptions/quality improvement initiatives in the areas of wound, ostomy
 and continence including an outline of how the program need was identified, program
 development and implementation, and an evaluation of outcomes
- Review articles/systematic review of the literature; professional development issues and ethical issue articles facing our specialty
- Letters to the Editor (maximum 500 words)
- Questions for Continence Exchange (maximum 250 words)

Preparation of the Manuscript

- Must be submitted in English or French
- Referencing format National Library of Medicine (NLM) Citation

- Title page (include complete manuscript title; author(s) full names, academic degrees, affiliations; name, address, phone number, email address of corresponding author; conflict of interest; any disclosure of funding if applicable)
- Abstract a paragraph including:
 - Case study/clinical report background, introduction of case, conclusions
 - Research purpose, design, subjects and settings, methods, results, conclusions
 - Innovative programs/quality improvement purpose, design, subjects and settings, methods, results, conclusions
 - Review article/systematic review of the literature; professional development issues and ethical issues – introduction of topic and summary of most relevant points
- Key words provide 3 to 5 key terms, that are common to your literature review
- Key points, clinical take away
- Article must be double-spaced using a 12-point font size Times New Roman, 1" margins and submitted as a Word document

Original photos and diagrams/images will be accepted at 300 dpi resolution or greater. For
images owned by one of the authors it is the authors responsibility to ensure proper permission
has been granted and a release form, verifying this, will be required.

After Acceptance

All accepted submissions go through at least 2 revisions after peer review. It is very important to have these revisions done in a timely fashion in order to meet the publisher's deadlines. Following completion of all revisions, page proofs will be developed. The corresponding author will be asked to check the copyedited and typeset article before publication. It is the corresponding author's responsibility to ensure that there are no errors in the proofs. Changes that have been made to conform to the NSWOC Advance publication style will stand if they do not alter the authors' meaning. At this point in the process, only the most critical changes to the accuracy of the content will be made. Stylistic changes or reworking of previously accepted content will not be allowed at this point.
